On 5/5/2020 at about 11:40 A.M., Guillermo Barragan commented on a Facebook post regarding upcoming Freedom Rallies in CA; the poster, [REDACTED], used the heading "Free Encinitas & San Diego County" and publicly posted four flyers grouped together in one photo post (see attached printout). Barragan was the only commenter and stated the following, "No disrespect but what are we going to do? Just stand there screaming open up California while a bunch of like minded people drive by honking their horns? Past 3 protests I've been to have been just that. To be honest none of this is going to stop without bloodshed and things have to get worse before they get better. That's just my opinion." [REDACTED] responded, "then make it happen!" Barragan continued on stating, "been trying to but no one is with me! Im not going to be the only one. Why so people can cheer me on while i get murdered by cops like they cheered me on while me and two others got arrested at the beach? We have to all be in it or it's no go. Protesting is not the answer. We need mass disobedience."

Barragan was ultimately identified as an arrestee during the 4/25/2020 protests at Moonlight Beach in Encinitas. As Barragan was being escorted in the Sheriff's transport vehicle, he yelled to someone in the crowd, "I'll die for this bro"; there is ample BWC and media footage of Barragan's protesting with [REDACTED] and [REDACTED] present. Further research into Barragan revealed he approached a Chula Vista police officer on 3/18/2020 in a parking lot; [REDACTED] and [REDACTED] were present again but stayed in the car. Barragan appeared paranoid to the officer and complained about the COVID-19 restrictions. Barragan further theorized that law enforcement would go door to door taking citizens firearm like they did after Hurricane Karina. A firearms records check reveals Barragan to currently own a Glock 9mm handgun and a 12-gauge shotgun; he previously owned another handgun, rifle, and shotgun that are indicated as sold. It is believed Barragan will continue to attend planned demonstrations and continue his civil disobedience through violent means.

Based on the content of the attached reports, I hold the opinion that a GVRO is necessary to protect the public and prevent harm to the respondent or others. There are no lesser restrictive means to ensure public safety.

I declare under penalty of perjury under the laws of the State of California that the foregoing is true and correct.




