Re: Your Public Records Act Request, Which Was Received on February 1, 2021

Dear Mr. McMillan

This letter is a follow up to our response on March 1, 2021. The County incorporates by this reference all of its responses and exemptions, inclusive, outlined in its response dated March 1, 2021. We have located responsive document to your public records request as outlined below:

Request No. 36: All records reflecting change in registration status submitted to the statewide voter system by the county due to felony status processed between September 1, 2020 and November 10, 2020.

Response: The County includes the Daily Audit/NVRA Statistics Report reflecting a total of zero.

Request No. 38: All records reflecting change in registration status submitted to the statewide voter system by the county due to county death records reflecting voter to be deceased processed between September 1, 2020, and November 10, 2020.

Response: The County includes the Daily Audit/BVRA Statistics Report reflecting a total of thirty-seven (37).

Request No. 39: All records reflecting the total cancellations directed by the Secretary of State processed by the county between September 1, 2020, and November 10, 2020.

Response: The County includes the Daily Audit/NVRA Statistics Report reflecting a total of seventy-two (72) cancelled voters,

Request No. 46: Those documents reflecting the date of each subsequent or supplemental rosters, after the initial roster for the purpose of conducting the 2020 General Election.

Response: The County provides the Ballots Issued by Issue Date in response to this request.

Request No. 47: All certifications executed by any county election official for the November 3, 2020 General Election.

Response: The County provides the Certification of Election in this response.

Request No. 48: The number of ballots determined by the county through adjudication for the November 3, 2020 Election.

Response: The information is included in the Certification of Election included with this response.

Request No. 49: All ballots duplicated by the county through adjudication for the November 3, 2020 election.

Response: A total of 435 ballots were adjudicated. See attached reports,

Request No. 50: Those documents that identify the records of ballots duplicated for the November 3, 2020 election.

Response: The County provides its Ballot Duplication Log for the November 3, 2020 General Election.

Request No. 51: Those documents that identify the records of ballots adjudicated for the November 3, 2020 election.

Response: See response for Request No. 50 above.

Request No. 63: All electronic documents containing the phrase "Eric Coomer."

Response: The County has no responsive documents for this request.

The County is still researching to determine if other responsive documents exist. It is estimated the county should complete its research on or before April 21, 2021

Moreover, much of the information you seek would require an application for voter registration information, pursuant to Elections Code §§ 2187, 2188 and 2194, as well as 2 California Code of Regulations, §19001, et seq. As of the date of this letter Plumas County Registrar of Voter has not yet received a complete application for voter information and applicable fee of \$50.


