Regarding the 1<sup>st</sup> requirement:

### Requested:

- Remove the boxes that I have crossed off in red. Removed. The "Sample Ballot" header in grey box for the first card is retained.
- 2. Increase the font sizes at least up to 3 points more from what they are for all the Candidates, Contests, Headings occupations and prop/measure text.
  - a. Candidate up to 12 point <mark>- done</mark>
  - b. Occupations up to 11 point done Contests – up to 14 point -> 13 points
  - c. Prop / Measure Text up to 12 point done Headings – up to 14 point -> 13 points
- 3. Make the ballot single column. Only if the contest is long then go to 2 columns. Its ok to go into multiple pages. Here is what the customer said

It is ok to take up multiple pages. We realize that some contested may wrap into a second column, but the standard should be single column.

There are three contests only that couldn't fit 11in ballot, so they are wrapped into a second column, all the rest are single column.

As mentioned previously, our original idea was the following:

- All candidacy contests to put on the first card -> Due to font enlargement and the number of candidacy
  contests per ballot type, they couldn't all fit on the first card, so I went through all first ballot cards and
  moved the contests that were causing issues to the second card.
- Proposition on the second card First part of the propositions is moved to the third card not to interfere
  with the candidacy contests. Second part couldn't fit into the ballot size and it's moved further.
- Measures on the third card Second part of the propositions is moved to the fourth card and grouped along with measures.

In case all candidacy contests of a ballot type do fit on the first card, we don't have second card, just first, third and fourth.

  - 1. A file that contains all contest on one ballot.
    - 1. Page size 8.5 x 11
    - 2. This will be used as a comprehensive sample ballot page in a comprehensive Voter Information Guide.
    - 3. It will also be used to create facsimile ballots in additional languages to comply with election code 14201

Regarding the placements of the contests on the cards, since there are 172 contest it had to be done partially manually and could place 4 contests per card. We couldn't render more contests on 11in ballot. With this kind of solution, we have some unused space on the cards, however if better usage of space is necessary, it would require another couple days of work.

Also attached are samples for the 2<sup>nd</sup> requirement of Comprehensive ballots. Please let me know if these are good for you. If yes, then I will get these created for you. Below are comments/updates from the team:

## Regarding the 1<sup>st</sup> requirement:

### Requested:

- Remove the boxes that I have crossed off in red. Removed. The "Sample Ballot" header in grey box for the first card is retained.
- 2. Increase the font sizes at least up to 3 points more from what they are for all the Candidates, Contests, Headings occupations and prop/measure text.
  - a. Candidate up to 12 point done
  - b. Occupations up to 11 point done Contests – up to 14 point -> 13 points
  - c. Prop / Measure Text up to 12 point done Headings – up to 14 point -> 13 points
- 3. Make the ballot single column. Only if the contest is long then go to 2 columns. Its ok to go into multiple pages. Here is what the customer said

It is ok to take up multiple pages. We realize that some contested may wrap into a second column, but the standard should be single column.

There are three contests only that couldn't fit 11in ballot, so they are wrapped into a second column, all the rest are single column.

As mentioned previously, our original idea was the following:

- All candidacy contests to put on the first card -> Due to font enlargement and the number of candidacy
  contests per ballot type, they couldn't all fit on the first card, so I went through all first ballot cards and
  moved the contests that were causing issues to the second card.
- Proposition on the second card First part of the propositions is moved to the third card not to interfere
  with the candidacy contests. Second part couldn't fit into the ballot size and it's moved further.
- Measures on the third card Second part of the propositions is moved to the fourth card and grouped along with measures.

In case all candidacy contests of a ballot type do fit on the first card, we don't have second card, just first, third and fourth.

Attached are samples of BT 1.

Regarding the:

- 2. **Second Requirement** for comprehensive pages
  - 1. A file that contains all contest on one ballot.
    - 1. Page size 8.5 x 11
    - 2. This will be used as a comprehensive sample ballot page in a comprehensive Voter Information Guide.
    - 3. It will also be used to create facsimile ballots in additional languages to comply with election code 14201

Regarding the placements of the contests on the cards, since there are 172 contest it had to be done partially manually and could place 4 contests per card. We couldn't render more contests on 11in ballot. With this kind of solution, we have some unused space on the cards, however if better usage of space is necessary, it would require another couple days of work.

Please review and let us know. You can find attached PDFs, ballots are divided by languages and all in one as well.
